Funding Overview

NextGen Grantmakers, a Youth Participatory Grantmaking initiative in partnership with Vision for Children at Risk (www.visionforchildren.org) is a youth-led and youth-serving grant opportunity designed to empower young people (10-24) by supporting initiatives that promote leadership, safety, mental well-being, and professional growth. This RFP invites youth-led or youth-serving projects to apply for up to \$20,000 of funding to support ideas that make a positive impact in their communities.

Priority will be given to proposals that develop safety programs for youth; address mental health, well-being, and emotional intelligence; and foster youth leadership and personal growth. Successful projects will be youth-led or meaningfully involve youth, create positive community change, demonstrate creativity and originality, promote equity and inclusion, and present realistic, achievable plans.

- Prospective applicants should serve youth in one or more of the following areas: the Greater St. Louis area (St. Louis City, St. Louis County, St. Charles, Jefferson, and Franklin County) and Illinois (Madison, Monroe, and St. Clair County).
- Projects should serve youth ages 10-24
- Applications will be reviewed by the Youth Advisory Board, which is comprised of young people ages 12-24
- Applications are due by Friday, September 26th, 2025 at 11:59 pm.
- If the applicant does not have a 501(c)(3) tax status, the applicant is eligible to apply with a fiscal sponsor.
